

NOTICE

Any qualified elector who is handicapped or elderly and assigned by his or her County Board of Elections to an inaccessible polling place has the right to cast an alternative ballot on or before Election Day. An alternative ballot can be returned up to the close of the polls on Election Day.

The Electors of Washington County are further advised that irrespective of the accessibility of a qualified elector's polling place, a qualified elector who is unable, because of a permanent or temporary disability or illness, to attend the polling place or to operate the voting system provided at the polling place without assistance, has the right under the Pennsylvania Election Code to apply for and vote by absentee ballot. Please contact the Washington County Elections office for more information on voting by absentee ballot.

Please note that applications for absentee ballots must be received in the Elections Office no later than 5 p.m. Tuesday, October 31, 2017.

Completed ballots must be received no later than 5 p.m. Friday, November 3, 2017.
