If you spoil your ballot, do not erase, but ask for a new ballot.

### STRAIGHT PARTY ( Vote for ONE )

TO VOTE FOR ALL CANDIDATES OF A PARTY **SELECT ONE STRAIGHT PARTY.** TO VOTE FOR AN INDIVIDUAL CANDIDATE OF ANOTHER PARTY OR ANY INDIVIDUAL CANDIDATES REGARDLESS OF PARTY AFTER VOTING A STRAIGHT PARTY, VOTE THE OVAL OR BLOCK NEXT TO THAT CANDIDATE'S NAME ON THE BALLOT. ONLY THOSE CANDIDATES INDIVIDUALLY VOTED FOR IN THE OFFICE BLOCK WILL RECEIVE A VOTE. **STRAIGHT PARTY VOTES CAST FOR CANDIDATES NOT DEMOCRATIC OR REPUBLICAN WILL ONLY COUNT IF CAST IN THE REGION WHERE THEY ARE RUNNING.**
