To vote for a person not on the ballot, manually WRITE IN his or her name in the space provided, then blacken the corresponding oval (). Use only pen or pencil. If you spoil your ballot, do not erase, but ask for a new ballot.

STRAIGHT PARTY (Vote for ONE)

TO VOTE FOR ALL CANDIDATES OF A PARTY SELECT ONE STRAIGHT PARTY. TO VOTE FOR AN INDIVIDUAL CANDIDATE OF ANOTHER PARTY OR ANY INDIVIDUAL CANDIDATES REGARDLESS OF PARTY AFTER VOTING A STRAIGHT PARTY, VOTE THE OVAL OR BLOCK NEXT TO THAT CANDIDATE'S NAME ON THE BALLOT. ONLY THOSE CANDIDATES INDIVIDUALLY VOTED FOR IN THE OFFICE BLOCK WILL RECEIVE A VOTE. STRAIGHT PARTY VOTES CAST FOR CANDIDATES NOT DEMOCRATIC OR REPUBLICAN WILL ONLY COUNT IF CAST IN THE REGION WHERE THEY ARE RUNNING.

**PROPOSED CONSTITUTIONAL
AMENDMENT**
CRIME VICTIMS RIGHTS

SHALL THE PENNSYLVANIA CONSTITUTION BE AMENDED TO GRANT CERTAIN RIGHTS TO CRIME VICTIMS, INCLUDING TO BE TREATED WITH FAIRNESS, RESPECT AND DIGNITY; CONSIDERING THEIR SAFETY IN BAIL PROCEEDINGS; TIMELY NOTICE AND OPPORTUNITY TO TAKE PART IN PUBLIC PROCEEDINGS; REASONABLE PROTECTION FROM THE ACCUSED; RIGHT TO REFUSE DISCOVERY REQUESTS MADE BY THE ACCUSED; RESTITUTION AND RETURN OF PROPERTY; PROCEEDINGS FREE FROM DELAY; AND TO BE INFORMED OF THESE RIGHTS, SO THEY CAN ENFORCE THEM?
