INSTRUCTIONS TO VOTERS: TO VOTE, BLACKEN THE OVAL (●) COMPLETELY next to the candidate of your choice. To vote for a person not on the ballot, manually WRITE IN his or her name in the space provided, then blacken the corresponding oval (●). Use only pen or pencil. If you spoil your ballot, do not erase, but ask for a new ballot.

STRAIGHT PARTY (Vote for one)

TO VOTE FOR ALL CANDIDATES OF A PARTY SELECT ONE STRAIGHT PARTY. TO VOTE FOR AN INDIVIDUAL CANDIDATE OF ANOTHER PARTY OR ANY INDIVIDUAL CANDIDATES REGARDLESS OF PARTY AFTER VOTING A STRAIGHT PARTY, VOTE THE OVAL OR BLOCK NEXT TO THAT CANDIDATE'S NAME ON THE BALLOT. ONLY THOSE CANDIDATES INDIVIDUALLY VOTED FOR IN THE OFFICE BLOCK WILL RECEIVE A VOTE. STRAIGHT PARTY VOTES CAST FOR CANDIDATES NOT DEMOCRATIC OR REPUBLICAN WILL ONLY COUNT IF CAST IN THE REGION WHERE THEY ARE RUNNING.

**PROPOSED CONSTITUTIONAL
AMENDMENT
CRIME VICTIMS RIGHTS**
